1. Sealed tenders should reach Sukaar Foundation Head Office North Colony Mithi Tharparkar, Sindh, Pakistan on or before **1430 Hrs. on April 12, 2018** and should be clearly marked "TENDER - Not to be opened before **1430 Hrs. on April 12, 2018**. Tender is available at Sukaar foundation head office Mithi also bidder may download from website: www.sukaarfoundation.org
2. Tenders will be opened on the same day i.e. **April 12, 2018 1430 Hrs.** if all the bidder submit their tender before date then the tender may open before due mention date.
3. In case a public holiday is announced by the Government (Due to any reason) the tender will be opened the next working day at the same time and venue.
4. Samples of item mentioned in tender pack must be submitted along with the bid or on next day of tender opening. Non submission of samples might make the bidder in-eligible / unqualified.
5. Tender committee reserves the right to change the quantities or cancel/reject any or all offers without assigning any reason.
6. The Supplier must quote only one option for each item. Bids received with more than one options and rates may be rejected.
7. Bidders can apply for a single or multiple Lots. Sukaar Foundation reserves the right to divide the order Lot wise.
8. Suppliers must not be engaged in any corrupt, fraudulent, collusive or coercive practices including but not limited to applying/ bidding by multiple names / companies. If any bidder is found to be involved in such practices his/her bid may be rejected and the companies in question permanently black listed.
9. Lowest price will not be the sole criteria; quality of Material and previous experience will also be considered.
10. Quotations must cover all above aspects on company letter head with address phone/fax number.
11. 2. Cost must be given in Pak Rupees including all applicable taxes.
